

Livestock Campground Rules & Guidelines

1. Camping: limited camper and trailer space is available for livestock exhibitors only.
2. Clubs and Chapters **must** submit reservations as a group if they plan to camp together, if you have slide outs you must state that on forms, are spaces are small you may have to rent 2 spaces to accommodate slide outs.
3. All fees must accompany the reservations.
4. Spaces will be assigned "Wagon Train" Style with each group together.
5. **Fees: \$15.00 per night per unit** includes two vehicles parking.
6. Due to the crowded conditions in the campgrounds, it is imperative that each reservation form states the specifics regarding their RV (i.e. type, length, etc.)
7. No reservations will be accepted prior to January 15, 2010
8. **Each Camper and/ or Trailer site must have an Adult (25 years or older) assigned to each. This Adult's name and a cell phone or telephone number must be registered in the Livestock Office prior to receiving the space permit.**
9. You must check in at the Livestock Office to pick up your Trailer Space permit before opening day of Fair, May 15th, 2010.
10. Permits must be displayed on the Units at all times.
11. The use of intoxication substances and/ or drugs is prohibited. Any Junior Exhibitor under the influence will be removed, along with his or her Livestock and will forfeit all premiums, awards and Auction eligibility.
12. Fair management has set an 11 P.M. Curfew. All Junior Livestock Exhibitors that are camping on grounds are to be in their quarters by 11 P.M. No loud noises, radios, parties, etc. will be permitted or tolerated.
13. FFA Advisors and volunteer leaders of the 4-H clubs of San Bernardino County will assist Fair management in enforcing these rules.
14. **No dogs permitted on Fairgrounds or in the Campground area. No Exceptions!!!**
15. No Automobiles will be allowed traveling through the Campground between 10:30 P.M. and 5 A.M.
16. Clubs and Chapters are responsible for keeping their designated areas clean. Violators will be ejected from the ground.
17. Exhibitors are not permitted to sleep in the livestock Barns.
18. Fair management will support any and all Club and Chapter special rules as long as they do not contradict San Bernardino County Fair Rules.
